You may all recall your early years in grade school during Thanksgiving season when you were asked to draw a picture depicting something for which you were thankful. Predictably, most of us drew pictures of family, of bountifully laden tables of turkey and trimmings, of turkeys (remember tracing your hands with crayons!), of pilgrims and native people and the "first Thanksgiving" (history defies that construction), and of trees and plants with the brilliance of fall colors. I remember one of my schoolmates, Alberto, drawing something rather unusual, assumingly unrelated. He drew a picture of new sneakers. Yes, sneakers; Converse, black, high-top, sneakers. I recall the teacher, Mrs. Sproul, being somewhat puzzled, asking Alberto to talk about his drawing. She asked him about the sneakers and to whom they belonged. The back-story is that Alberto, like many of us in our community, was poor. He and his family had little in the way of worldly possessions. He walked barefoot to school on his first day. He had no shoes. Our grade school served much of the povertystricken, small community of my youth and to its credit, recognized the disfavor of profound need. His mother and Laura Collins, Principal at Roosevelt campus, conversed about how much Wolfgang enjoys coming to school now that he has found a place at the Roosevelt Falk School location! Falk moved out of its campus on Delaware Avenue in Buffalo when the doors opened at the former Theodore Roosevelt School in Kenmore this past September. Falk School has a lease agreement with the Kenmore Town of Tonawanda Union Free School District and operate a K-6 program at the site. The school has been approved by the New York State Department of Education to serve an additional 66 students, bringing its capacity to over 600, including all three campuses and four satellite locations.

## SHINING A LIGHT ON DOMESTIC VIOLENCE Fashion Show with a Twist helps to build awareness and educate the community.

It was not hard to get wrapped up in the excitement at Child & Family Services' annual Fashion Show with a Twist. There was shopping to be done, baskets to be won, fashions to wish for and delicious food to be eaten, but we all remembered the real reason of the event - bringing awareness to domestic violence. It was a time to understand the impact Haven House, Erie County's only domestic violence shelter, has on our community and the people in it. Most importantly, the event was also a time to recognize and appreciate the journey of a domestic violence survivor.

EVERY YEAR, FIVE MILLION CHILDREN WITNESS DOMESTIC VIOLENCE. Domestic violence remains one of the most underreported crimes in the United States, occurring across all demographics. Over the past two years, New York State ranks the highest in the nation for having the greatest need for domestic violence services. We are fortunate to have Haven House in the community, providing lifesaving services to help victims become survivors.

Jill, a domestic violence survivor who modeled in this year's event, attributes the staff at Haven House for encouraging her to escape her abuser. "At Haven House, my support system there felt my
